## FedEx International Priority® Freight

FedEx provides one of the **fastest global freight services** for shipments weighing **between 68 kg and 1,000 kg per item**. This service has all the benefits of an express service, and has four delivery options: door-to-door, from sender to destination airport, from departure airport to recipient, from airport to airport. All items must be forkliftable, shrink-wrapped and/or banded.

### Terms and conditions

#### CARRIER LIABILITY

Unless the Sender enters a higher Declared Value for Carriage on the air waybill, the liability of FedEx is limited to the higher of **a)** the amount provided by the applicable international treaty (including Warsaw and CMR Convention) or **b)** EUR 22/kg. FedEx does not provide cargo liability or all-risk insurance but the Sender may pay an additional charge for Declared Value for Carriage above these limits, subject to an incremental charge of CZK 29 per CZK 2,740 declared value.

Specific items such as artwork, film, antiques, glassware, jewellery, furs, watches, etc. are limited to a maximum declared value for carriage of 500 US\$ per shipment or 9.07 US\$ per US pound, whichever is greater. Liability of claims requires notice of claims within strict time limits. FedEx's liability is subject to strict and detailed terms and conditions.
