CARRIER LIABILITY COVERAGE Item 420	See Item 420 in the FedEx Freight and FedEx National LTL Rules Tariffs
COLLECT ON DELIVERY (COD) Item 430	COD amount to be collected - 6.0% of the COD amount, \$75 minimum charge, \$25 for changes to COD terms
DETENTION Item 500	With power - \$37.10 per 28' trailer each 15 minutes, \$66 minimum charge Without power - \$101 per 28' trailer each 24 hours
EXHIBITION SITES Item 520	Rated at Class 150, actual class or applicable exception class (whichever is greater) plus \$78 per shipment, see rule for additional charges to specific locations
EXTRA LABOR Item 560	\$67 per person per hour or fraction thereof, \$266 minimum charge
EXTREME LENGTH Item 530	\$55 per shipment when the shipment includes any piece exceeding 15 ft. in length
HAZARDOUS MATERIAL HANDLING Item 920	\$16 per shipment
INSIDE PICKUP OR DELIVERY Item 566	\$7.38 per cwt., \$77 minimum charge, \$781 maximum charge
LIFTGATE SERVICE Item 890	\$5.15 per cwt., \$76 minimum charge, \$251 maximum charge
LIMITED ACCESS PICKUP OR DELIVERY Item 750-8	\$80 per shipment (Includes: construction sites, mine sites, churches, schools, etc.)
MARKING OR TAGGING FREIGHT Item 580	\$3.54 per package or piece, \$50 minimum charge
NON-BUSINESS TIME SERVICE Item 753	\$110 per person per hour or fraction thereof, the minimum charge for non-business hours is \$222, non-business days \$411
NOTIFICATION PRIOR TO DELIVERY Item 750-3	\$34 per shipment
PROTECTION FROM FREEZING SERVICE Item 810	\$1.91 per cwt., \$19 minimum charge
REDELIVERY Item 830	\$7.76 per cwt., \$77 minimum charge, \$813 maximum per shipment
RESIDENTIAL PICKUP OR DELIVERY Item 750-2	\$80 per shipment
SORTING AND SEGREGATING Item 887	\$1.77 per cwt. or \$0.66 per piece, whichever produces the higher charge, \$72 minimum charge
STORAGE Item 910	\$2.22 per cwt. per day, minimum charge \$21 per shipment per day, not less than \$77 per shipment, see rule for maximum charges
