How does FedEx International Priority DirectDistribution work?

Simple integrated processes



Process 1

At the shipment origin, FedEx automation device works with the customer's order processing system to transmit final destination information.

Process 2

FedEx automation device electronically consolidates the shipment and uploads customer information in the FedEx information systems.

Process 3

Customs-clearance procedures begin inflight using a Consolidated Commercial Invoice transmittal for a single customs entry and clearance of the packages under the master air waybill.

Process 4

Electronic deconsolidation occurs at clearance gateway, and shipments are delivered to final recipients.

When multiple packages ship to a single destination country, each individual item must clear customs, then be processed and delivered by a local vendor. All the while, time is of the essence.

Now, change the scenario to one consolidated shipment that's being cleared through customs while in flight, *prior to arrival*, through a Consolidated Commercial Invoice, so it enters your target country and is cleared through customs as a single unit. From there, your products are delivered via FedEx delivery service—reliably, on time, every time.
