



Shipping Dangerous Goods

Dangerous goods are everywhere. Perfume, oil paint art kits, and laptop computers are all considered dangerous goods during transport. Under some circumstances these everyday items can harm people, property, and the environment. Protect your shipment and yourself by identifying dangerous goods and properly packaging and preparing every shipment.



Identify Your Shipment

Refer to the International Air Transport Association (IATA) and International Civil Aviation Organization (ICAO) for the correct identification, classification (including UN or ID number), Proper Shipping Name, hazard class and, if applicable, subsidiary risk and Packing Group.

Package Your Shipments Correctly

Some dangerous goods have specific packaging, labelling, and marking requirements. All require a completed Shipper's Declaration or Dangerous Goods form. For more information on the Shipper's Declaration and dangerous goods requirements, please visit [fedex.ca/dg](https://www.fedex.ca/dg)

Protect Yourself

Shippers who do not prepare their packages according to IATA and ICAO regulations can be fined by regulatory authorities and may even face criminal prosecution and imprisonment. A list of registered dangerous goods training organizations is available at **Transport Canada's website** . A shipper must receive dangerous goods aviation training in order to ship dangerous goods with FedEx.

Dangerous Goods Update

The following items were recently identified as causing catastrophic incidents during transport:

- Oxygen generators/oxidizing cases
- Batteries of all types
- Flammable gas torches
- Gasoline-powered devices of all types
- Fireworks
