### Overview of previous updates, as of 15 April 2025

Effective May 5, 2025, for all shipments from Israel to Europe, the Demand Surcharge will be suspended.

Effective February 1, 2025, we will implement the following Demand Surcharge changes for FedEx shipments:

- For intra-Europe (export and import) Priority and Economy shipments, the Demand Surcharge will be suspended. This suspension does not apply to shipments to and from Israel.
- For all shipments from Europe to US and Canada, LAC, MEISA, Australia and New Zealand, and Rest of the World, the Demand Surcharge will be suspended.

Effective October 14, 2024, we will implement the following Demand Surcharge changes for FedEx shipments:

- For all shipments from Europe to Israel and Israel to Europe, a Demand Surcharge will be applied at €0.45 per kilo.
- For all shipments from Europe to LAC and to Australia and New Zealand, the Demand Surcharge will be re-instated at €0.50 per kilo.
- For all shipments from Europe to MEISA and Rest of World, the Demand Surcharge will be re-instated at €0.40 per kilo.
- For all shipments from MEISA to Europe, the Demand Surcharge will be re-instated at €0.68 per kilo.

Effective September 16, 2024, we will implement the following Demand Surcharge changes for FedEx shipments:

- For all shipments from China / Hong Kong SAR China to Europe, the Demand Surcharge will be increased from €0.80 to €1.82 per kilo.
- For all shipments from APAC / Mexico to Europe, the Demand Surcharge will be re-instated at €1.00 per kilo.
- For all shipments from Europe to US / Canada, the Demand Surcharge will be re-instated at €0.50 per kilo.
- For intra-Europe (export and import) Priority shipments, the Demand Surcharge will be re-instated at €0.30 per kilo.
- For intra-Europe (export and import) Economy shipments, the Demand Surcharge will be re-instated at €0.10 per kilo.

For all shipments from China to Europe, a surcharge of €0.80 per kilo begins August 12, 2024.

For international (export and import) Priority and Economy shipments, the Demand Surcharge will be suspended as of April 29, 2024.

For intra-Europe (export and import) Priority shipments, the Demand Surcharge will be suspended as of January 1, 2024.
