## Value Added Services<sup>(1) (2)</sup>

You can customise your FedEx services to your needs (or the needs of your recipients) with value added services from FedEx Express. The following are descriptions of the fees applicable to value added services.

<b>Dangerous Goods</b> Only available on Express Services.	<p>FedEx Express Dangerous Goods services allow the shipping of regulated dangerous substances and materials including door-to-door delivery and customs clearance.  Applicable fee depends on the Dangerous Goods type:</p> <ul style="list-style-type: none"> <li>• <b>Accessible Dangerous Goods (ADG)</b>  The content of package must be accessible during transit for security reasons.</li> <li>• <b>Inaccessible Dangerous Goods (IDG)</b>  The content of package does not have to be accessed during transit and can be mixed with other freight.</li> <li>• <b>Dry Ice (DI)</b>  Dry ice is a hazardous commodity that requires special handling, subject to simplified regulations. This means it can be offered in locations where fully regulated Dangerous Goods services are not offered.</li> </ul> <p>In case a shipment contains both Dry Ice and Dangerous Goods, only the respective Dangerous Goods surcharge applies. <b>Diplomatic Bag (Diplomatic Mail)</b>	<p>We accept diplomatic shipments between embassies and consulates of the same country/territory for delivery by International Priority service. As per the Vienna Convention of 1961, Diplomatic Bags receive diplomatic immunity from inspection or delay.</p>	None

<b>FedEx Customs Brokerage Services</b>	FedEx Express offers a seamless standard customs clearance process to enable on-time delivery of your goods. We also offer a range of specialised inbound clearance solutions subject to an additional fee (VAT may apply at the applicable rate). <b>FedEx® Electronic Trade Documents*</b>	With FedEx Electronic Trade Documents (ETD) you can streamline your international shipments by uploading your customs documentation electronically. ETD reduces the amount of paper you print for each shipment, allows for faster pickup and helps to pre-clear your shipments, reducing the risk of your shipment being delayed in customs. ETD feature needs to be activated within your automated shipping tool.	None
<b>FedEx® Global Returns or FedEx Import Shipping Print Label</b>	Create return or import shipping labels on your computer or shipping system. Then simply print and provide the label to your customer or send it as PDF via email.	None
<b>FedEx Global Returns or FedEx Import Shipping Email Label</b>	Create return or import shipping labels and allow your customers to access these electronically and edit them as needed.	OMR 1.00/label
<b>FedEx International Broker Select Option</b>	A fee applies to FedEx International Broker Select (BSO) shipments when all of the following occur: <ul style="list-style-type: none"> <li>• A broker (other than FedEx Express or FedEx Express designated) clears the shipment.</li> <li>• FedEx Express picks up the shipment at the customer's broker location and delivers it to the final consignee.</li> <li>• The consignee's location is served by a different clearance point than the broker's clearance point.</li> </ul>	OMR 7.00/shipment
<b>Hold at FedEx Location</b>	As an alternative to a business or residential delivery, you can choose Hold at FedEx Location (HAL), and have recipients pick up their shipments at a FedEx Express location. Subject to availability.	None
<b>FedEx® Delivery Signature Options</b>	The following delivery signature options <sup>(4)</sup> may be chosen at the time of booking your shipment: <b>1. No Signature Required:</b> FedEx will attempt to obtain a signature at the delivery address. If no one is available to sign, FedEx will deliver the package in a safe place without obtaining signature. <b>2. Indirect Signature Required:</b> FedEx will obtain a signature from someone at the delivery address, from a neighbour or from a building manager. If no one is available to sign, FedEx will attempt to redeliver the package. <b>3. Direct Signature Required:</b> FedEx will obtain a signature from someone at the delivery address only. If no one is available to sign, FedEx will attempt to redeliver the package. <b>4. Adult Signature Required:</b> FedEx will obtain a signature from any person of legal age at the delivery address, subject to sighting of a valid ID. If no one eligible to sign is available, FedEx will attempt to redeliver the package. Legal age will vary depending on the destination country/territory and is governed by local legal age of an adult, not the legal age to purchase specific products (i.e. alcohol).	<b>1.</b> None <b>2.</b> None. Additional Handling Surcharge	Effective January 6, 2025, FedEx will assess an Additional Handling Surcharge per eligible package for international multi-piece shipments, instead of per shipment.	
	<b>Package Services</b> An Additional Handling Surcharge applies to any package that meets any of the following criteria: <b>Dimension</b> <ul style="list-style-type: none"><li>• measures greater than 121 centimeters along its longest side;</li><li>• measures greater than 76 centimeters along its second-longest side;</li><li>• measures greater than 266 centimeters in length and girth (L+2W+2H).</li></ul> * Subject to a 40-lb. minimum billable weight.	OMR 12/package
	<b>Weight</b> <ul style="list-style-type: none"><li>• ** has an actual weight greater than 25kg.</li></ul>	OMR 12/package
	<b>Packaging</b> <ul style="list-style-type: none"><li>• is not fully encased in an outer shipping container;</li><li>• is encased in an outer shipping container not made of corrugated fibreboard (cardboard) materials, including but not limited to metal, wood, canvas, leather, hard plastic, soft plastic, or expanded polystyrene foam (e.g. Styrofoam);</li><li>• is encased in an outer shipping container covered in shrink wrap or stretch wrap;</li><li>• is round or cylindrical, including (without limitation) mailing tubes, cans, buckets, barrels, tires, drums, or pails;</li><li>• is bound with metal, plastic, or cloth banding, or has wheels, casters, handles, or straps (e.g., a bicycle) (including packages where the outer surface area is loosely wrapped, or where the contents protrude outside the surface area);</li><li>• could become entangled in, or cause damage to other packages or the FedEx sortation system.</li></ul> We reserve the right to assess additional handling charges for packages that require special handling or that require FedEx to apply additional packaging during transit. If a package is eligible for 2 or all 3 Additional Handling Surcharges, only 1 with greater charge will apply. 	<b>Freight Services</b> A surcharge applies to any freight handling unit that measures greater than 157 centimeters along its longest side. We reserve the right to assess additional handling charges for freight and any freight handling unit that requires special handling during transit.	OMR 19.20/package
Additional Handling Surcharge – Non-stackable <sup>(5)</sup>	Effective January 6, 2025, FedEx will assess an Additional Handling Surcharge per eligible package for international multi-piece shipments, instead of per shipment. A surcharge applies to any freight handling unit that is non-stackable, which means the piece, skid, or pallet cannot be stacked vertically in a safe and secure manner. Examples include, but are not limited to, non-stackable freight handling units that: <ul style="list-style-type: none"><li>• do not have a flat and stable top or base;</li><li>• may be damaged if another piece is loaded on them; or,</li><li>• have flat and stable loading surfaces but are too narrow to safely and securely support other freight handling units (e.g. 1-2 barrels or drums).</li></ul>	OMR 100.00/package

Unauthorized Charges	<p>Effective July 14, 2025</p> <p><b>Package Services</b> An “Unauthorized Package Charge” will be assessed per package when any of the dimensional or weight limits below are exceeded.</p> <ol style="list-style-type: none"> <li>1. Measures greater than 274 centimeter along its longest side;</li> <li>2. Measures greater than 419 centimeter in length and girth - the length and girth is length plus (two times the height) plus (two times the width);</li> <li>3. Has an actual weight greater than 68 kgs.</li> </ol> <p>FedEx international packages will be subject to a 18 kgs. minimum billable weight when the package also meets the criteria of the Additional Handling Surcharge - Dimension.</p>	OMR 110/package
	<p><b>Express Freight</b> An “Unauthorized Freight Charge” will be assessed per freight-handling unit when any of the limits below are exceeded:</p> <ol style="list-style-type: none"> <li>1. Measures greater than 302 centimeter along its longest side;</li> <li>2. Measures greater than 762 centimeter in length and girth - the length and girth is length plus (two times the height) plus (two times the width);</li> <li>3. Has an actual weight greater than 1995 kgs.</li> </ol> <p>Shipments that exceed these limits are unauthorized and may be refused, returned to the shipper, or disposed of at FedEx sole discretion. However, FedEx may accept and deliver such shipments; if accepted, this surcharge applies. Package or handling-unit shape and dimensions may change during transit; FedEx may adjust shipment charges at any time.</p>	OMR 175/freight handling unit
Additional Line Item	<p>FedEx can provide clearance of shipments containing multiple commodities, however an Additional line item fee is applied to assign multiple tariff classifications. <b>Address Correction</b>	If a recipient's address on an Air Bill, Air Waybill or shipping label is incomplete or incorrect, we may attempt to find the correct address and complete delivery and we will assess a surcharge. If we are unable to complete delivery, we are not liable for failing to meet our delivery commitment. For FedEx International Broker Select, the address correction surcharge will apply if the broker's address is incomplete or incorrect on the Air Waybill or other shipping documentation. If we cannot determine the correct address or cannot reach the broker, we may attempt to contact the sender for address clarification or instructions to return the shipment. If we are unable to complete delivery under these circumstances, we will not be liable for failing to meet our delivery commitment.	OMR 3.50/shipment
<b>Advancement Fee</b>	Duties, taxes and other charges might be due when importing a shipment. FedEx may advance payment of these fees as assessed by customs on behalf of the payer. A fee will be based on the advanced amount paid.	Applicable on shipments with duty charge above OMR 1.00: 2% of the advanced amount or a minimum of OMR 5.80
<b>Broker Select Option</b>	A fee on shipments cleared by a broker (other than FedEx designated). FedEx picks up the shipment at the customer's broker location and delivers it to the final consignee. The consignee's location is served by a different clearance point than the broker's clearance point.	OMR 7.00/shipment
<b>Broker Document Transfer fee</b>	When a customer chooses to use a brokerage company other than FedEx to clear your inbound shipment, FedEx will charge a service fee to ensure all paperwork is provided to your selected broker.	OMR 7.00/shipment
<b>Clearance End Use</b>	To provide you with the most cost-effective and efficient customs brokerage service for processing your shipments. This includes duty-free or duty- and VAT-free clearance of your shipment when you provide us with the necessary documentation. <b>Import Permits and Licenses</b>	FedEx charges a fee for obtaining or renewing the import permit as required by local regulatory body. The charge applies to the duty and taxes payer.	OMR 15.00/shipment
<b>Other Government Agency</b>	The fee or fees are applied when documentation needs to be verified or an identity check has to be done by a government agency; however, fees can also be received by several agencies for the same shipment, such as local councils or commercial agencies.
