## Do you need hazardous materials training?

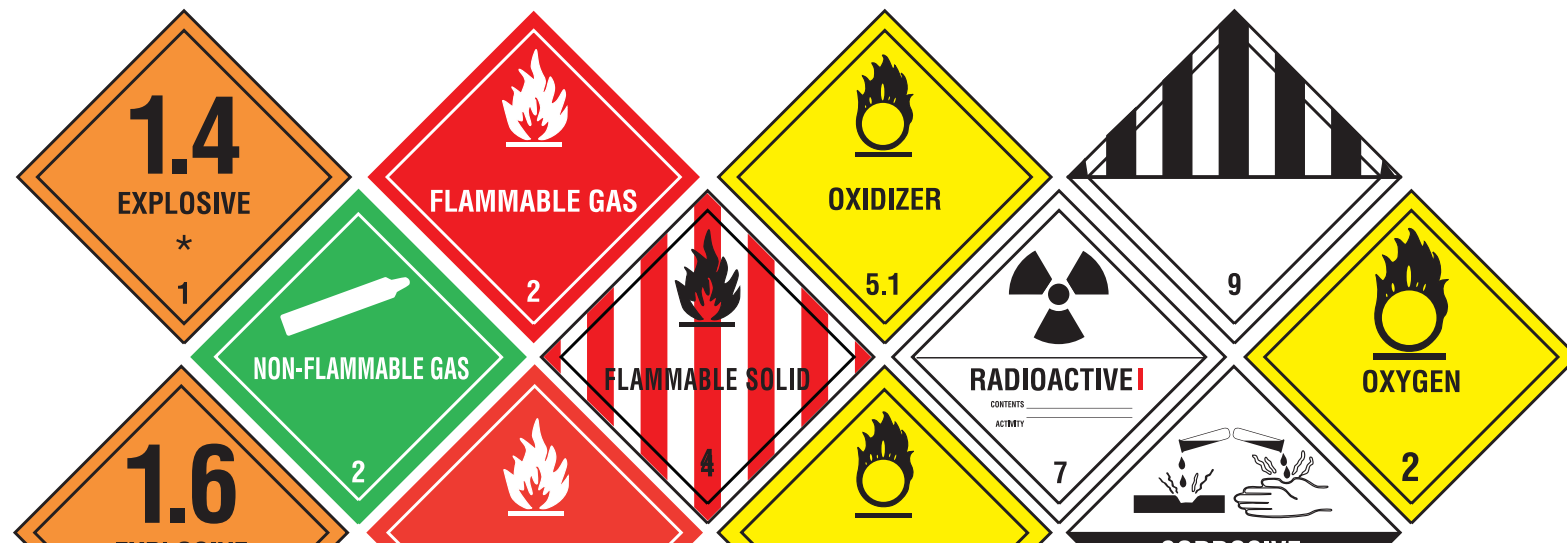
These seminars can help you safely transport hazardous materials such as, aerosols, lithium battery devices, ammunition, solvent-based paints, and drain cleaners.

Because the Department of Transportation (DOT) hazardous material regulations (HMR) mandate training for any individuals

involved in the transportation of hazardous materials. These training records will be reviewed if a DOT or other agency inspector visits your facility.
